Membership Definitions:

Associate Membership (AM) is open to all persons 18 years of age and older. Associate Members will enjoy all the privileges of the GLPWDC except the right to vote and hold office and shall not count in the determination of a quorum. After one year from the date of being accepted as an Associate Member, the member may apply for Full Membership. However, Associate Members need not apply for Full Membership and may continue as Associate Members for an indefinite period of time.

Junior Membership (JM) is open to persons 10 – 17 years of age. Junior Members will enjoy all the privileges of the Club except the right to vote and to hold office and shall not count in the determination of a quorum. Upon reaching the age of 18, a Junior Member will automatically become an Associate Member and may apply for Full Membership if they have been in the Club for at least one year.
